BAE Systems alone has invested nearly \$2 million in energy efficiency here in New Hampshire in the past 3 years and dropped its electricity usage by 2 percent – and they've still seen a 24 percent increase in their costs over the same period as energy prices, especially during periods of peak demand and insufficient supply, have risen far beyond that anywhere else in the country. Northern Pass is an essential part of our future energy infrastructure and we strongly urge the SEC to reopen its consideration of Northern Pass."
